Hi,

First, thanks for responding, very much appreciated.

Please

see http://iigwest.com/investigations/meier/emails/03_28_04_Randi_3A.pdf for Randi's statement, "Now, Michael has divined that I called the Meier case a "hoax." His powers of perception are **REMARKABLE**; he finds things where they don't exist! Wonderful!"

He had previously said, "No one is 'stumped' by the case. A child can see through the farce, though some adults have a problem with that." If you look up "farce" - as well as read all of the positions expressed by Randi (as well as CFI-West/IIG) you'll see that he and they indeed claimed that it was a hoax and Randi effectively retracts that statement, as quoted in first reference above.

Let's clarify also that the \$1,000,000 is NOT the issue here. Making a point out of it served the purpose, i.e. to get the discussion propelled further along and, ultimately, to get Derek Bartholomaeus of IIG to participate in our new film on the case, representing the professional skeptics.

Regarding the Statement by Jeff Wagg, General Manager for Randi's JREF, "If there's not enough evidence to support the model claim, the model claim is suspect." It was in response to my informing the skeptics that, "...I have several upcoming radio shows (two this week) and, unless you present proof to the contrary, I will be stating that you have absolutely failed to be able to prove your claims regarding the model, it's means of suspension and movement, etc. I will also then publish an article to that effect.

"However, I am again offering you the opportunity to speak up now and make your case, so that your position and response, evidence, etc. is absolutely clear. I think that it's quite reasonable to expect this after almost eight years."

The model claim also refers to the claims made, since 2001, by CFI-West, IIG, Michael Shermer, etc. that Meier hoaxed his UFO photos, films and video using models, since they acknowledge that he had no access to home computers, digital effects, etc. in the 1970s. But in the specific challenge above, it refers to a particular film of Meier's that Bartholomaeus claims was done with models (that constitutes a claim of a hoax by Bartholomaeus). The skeptics have to know that this claim is impossible to prove - and that they are incapable of duplicating the film to do so.

Bartholomaeus had also claimed that Meier used model trees because, he claimed, the trees all looked "similar" and, therefore, they were the "same" trees and, again therefore, model trees.

Of course, if you think that there's any doubt now that Randi, Bartholomaeus, CFI-West, IIG have retracted the model claims, please feel free to contact them and let them explain their positions more clearly.

Also, please let me know if you'd like a copy of the film.

BTW, regarding the NASA announcement of water on Mars, Meier published information on that in 1976 - and I have a copyrighted published book from 1993 that contains that transcript (which I first read in 1986).

Phil, you are about to explore something that will definitely challenge what you currently believe, at the very least.
